

GENERAL PROCUREMENT NOTICE

PROCUREMENT OF THE GOODS AND SERVICES
UNDER JAPAN'S GRANT AID 2009
FOR ECONOMIC STRUCTURAL ADJUSTMENT OF
THE REPUBLIC OF MALI

The Government of the Republic of Mali has received Grant Aid of Six hundred million Japanese Yen (JPY600,000,000.-) from the Government of Japan to purchase the goods and services incidental to such goods for public organizations and private sector companies in the Republic of Mali. Utilizing part of the Grant Aid, the following goods will be procured:

- Diesel Fuel Oil

Eligible source countries are all countries and areas except the Republic of Mali.

Firms or companies who are interested in supplying the goods should provide JAPAN INTERNATIONAL COOPERATION SYSTEM with the following information in English before 17:00 on August 11, 2010 (Japanese Time) either by fax or by e-mail.

- (1) Name and address of firms or companies
- (2) Name(s) of person(s) in charge
- (3) Telephone and facsimile numbers and an e-mail address, if available

By return, JICS will send the REGISTRATION FORM by e-mail (if available) or by facsimile. The REGISTRATION FORM is to be filled and returned with required documents (e.g. annual report) by registered mail, courier service or hand delivery before 17:00 on August 13, 2010 (Japanese Time). Only firms or companies who have submitted the complete REGISTRATIONFORM prior to a pre-qualification (P/Q) will be registered and P/Q will be carried out based on the REGISTRATION FORM. P/Q for the goods is scheduled for the date four (4) weeks after the date when this General Procurement Notice is issued. Criteria of P/Q for each category of the goods shall depend on the procurement conditions including the nature and scale of the goods, etc.

It should be noted, however, that JICS is not committed to extend invitations to tender to

ALL firms or companies which submitted the REGISTRATION FORM. Tender Invitations will be issued to the qualified firms or companies at a later date.

General Procurement Notice for other goods to be procured under the same grant may appear on JICS website later, therefore, these firms or companies who are interested in supplying the goods to the Republic of Mali shall be recommended to check the website on regular basis.
