Preface

Meeting Wide-Ranging International Cooperation Needs

The Japan International Cooperation System (JICS) was established as a public-service foundation in April 1989 upon authorization by the Minister for Foreign Affairs. As part of Japan's economic cooperation activities, JICS aims to promote high-quality international cooperation by providing appropriate and effective assistance in implementing bilateral grant activities. Since its establishment, JICS has been able to make its own modest contributions in the field, with the guidance of the Ministry of Foreign Affairs, the Japan International Cooperation Agency (JICA) and others, and with the support of various foreign government organizations and ODArelated bodies. I wish to express my sincere appreciation for the support and cooperation these parties have extended to JICS.

In the 19 years since JICS was created, the government's allocation for ODA out of the general budget peaked at 1.1687 trillion yen in FY1997 and has been declining ever since. In FY2008, the ODA budget stood at 700.2 billion yen, down 40.1% from the peak figure, so we must now work harder to implement efficient and effective aid within a limited budget. The "new JICA" was born in October 1, 2008 when the former JICA and the yen loan division of the Japan Bank for International Cooperation (JBIC) were amalgamated into a single organization for implementing ODA. This organizational change will help improve efficiency in the aid implementation process and strengthen coordination among assistance programs, which consist of technical assistance, grant aid and yen loans.

As a result, JICS faces a vastly changed environment and since January 2007, we have undertaken

to collect and analyze information mainly through our Office of Management Planning and draw up proposals to improve the efficiency of implementation procedures for aid schemes and also to develop new businesses to broaden the scope of our activities.

Since fiscal 2006, JICS has been handling avian flu support measures for the Japan-ASEAN Integration Fund (JAIF) and the World Organisation for Animal Health (OIE). In fiscal 2007, we conducted a feasibility study, delegated by JAIF, for road network improvements in Cambodia, Laos and Vietnam (Japan-CLV). We also won the contract, jointly with the Crown Agents of the United Kingdom, for a new United States' Millennium Challenge Account (MCA) grant aid project in Mongolia, and began operations for both CLV and MCA projects. JICS has thus become involved in a wide range of international cooperation projects delegated by international bodies.

JICS works steadily on existing projects; major projects supporting reconstruction in the regions affected by the Indian Ocean tsunami of 2004 as well as those in Iraq and in Afghanistan are coming to an end. The experience and know-how accumulated in implementing those projects have come into wide use in other projects such as grant aid for disaster prevention and reconstruction and grant aid for community empowerment. Thus, we have been working wholeheartedly



on existing and new projects.

Additionally, JICS serves as a procurement agent for various aid programs by the Japanese government such as grant assistance for environment programs, food aid and underprivileged farmers, intended to alleviate problems related to global environment and climate change issues and problems in developing countries due to higher food prices.

JICS will continue doing its best to further efficient use of Japan's ODA and maintain our reputation as a reliable organization, based on the JICS Vision and the JICS Code of Conduct.

This Annual Report describes JICS project results and activities in FY2007 and I hope that it will give you a better understanding of our organization's work.
