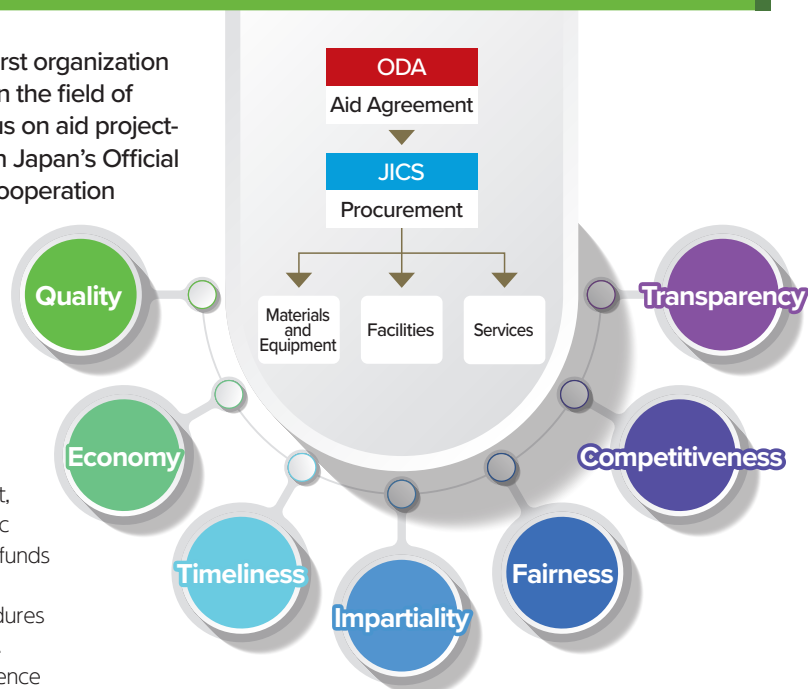
# Profile of JICS

Japan International Cooperation System (JICS) is the first organization in Japan to specialize in procurement operations within the field of international cooperation. JICS' activities primarily focus on aid project-related procurement and supervision operations within Japan's Official Development Assistance (ODA) programs and other cooperation programs with developing countries.

## The Role of the Procurement Agent

Procurement using ODA funds—which are sourced from taxes paid by Japanese citizens—must be carried out economically, in a timely manner and to the required level of quality. At the same time, it is imperative that the procurement process be impartial, fair, competitive and transparent. To achieve these objectives, purchases of materials, equipment, facilities and services need to be conducted according to public procurement rules through a tender process. Furthermore, aid funds must be managed appropriately.

To meet these requirements, JICS carries out these procedures as the procurement agent of the recipient-country government. A procurement agent possesses expert knowledge and experience relating to public procurement, materials and equipment, and other relevant aspects.

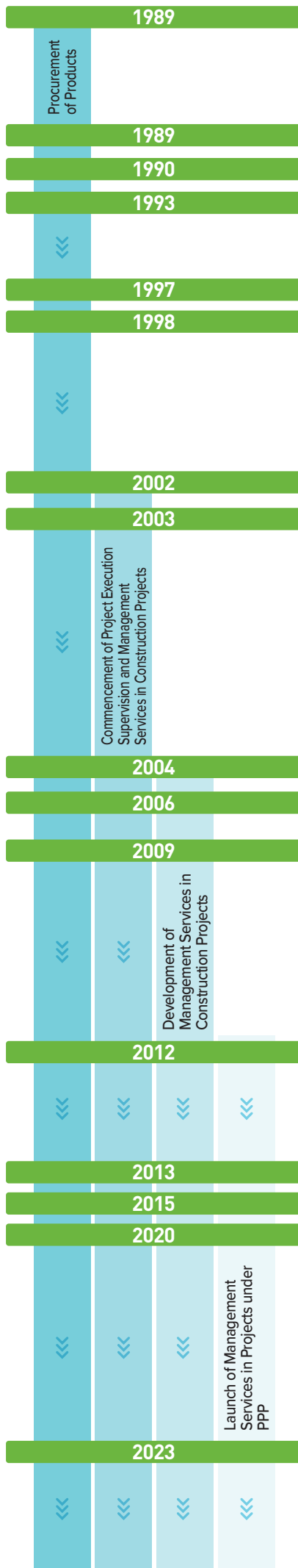

## A Message from the President

**Committed to the aims of peace, stability, and prosperity in the international community, JICS is devoted to fully engaging in international cooperation projects prioritized by the Government of Japan.**



### **Contributing through procurement to the assistance needs of a turbulent international community**

Cooperation among nations is paramount in addressing the many global issues faced by the international community. Even as we press forward toward the shared goal of achieving the SDGs, conflicts continue to erupt that threaten the international order. At the same time, we are reminded daily of the importance of the Government of Japan's international cooperation projects, particularly in terms of contributing to global peace and stability. To realize these projects, JICS has made it an organizational principle to respond with agility and precision by leveraging our procurement expertise.

### **Committed to a wide range of support, from long-standing issues to new global challenges**

In Africa, JICS, as a procurement agent, is engaged in project management, such as procuring food assistance for countries that need to strengthen their food security and constructing healthcare and treatment facilities. We promote procurement through our networks with these countries, making use of digital tools as appropriate given the conditions and circumstances in each country.

In the Asia-Pacific region, JICS procures a vast array of items that help boost maritime security capacity, environmental conservation, and action on climate change. We are also involved in projects that support digitalization, a key foundation for future prosperity. For example, a project to lay submarine cables to enhance telecommunications infrastructure was carried out jointly by six nations (both recipient nations and other donor nations). This was the first JICS initiative that promoted procurement in cooperation with multiple stakeholders.

For Ukraine, where the situation is a major concern for countries worldwide, we are cooperating on the procurement of equipment and materials needed to support Ukraine's recovery and reconstruction while coordinating with suppliers

and manufacturers to deal with issues of transportation and handover.

I would like to express my deepest gratitude for the support of the Ministry of Foreign Affairs of Japan, the Japan International Cooperation Agency (JICA), the governments of recipient countries, and related companies involved in international cooperation, for enabling us to press forward with our work despite the international situation's impact on our operations.

### **Aiming for optimal project implementation by deepening cooperative relationships with multiple actors involved with international cooperation projects**

JICS continues to make efforts to expand the scope of our operations. Examples include undertaking the international transportation of emergency vaccines to Africa and engaging in procurement and other services for the Official Security Assistance (OSA), which was established by the Government of Japan in 2023.

It is a source of pride for us, as a procurement agent, to play a part in the Government of Japan's efforts to support peace, stability, and prosperity in the international community, and to make that support tangible. We, at JICS, aim to be an integrator in international collaboration, building on our wealth of expertise in project management and international procurement. As such an integrator, all JICS employees strive to ascertain and connect the respective needs of the Government of Japan, the governments of recipient countries, related organizations, and related companies in order to maximize the impact of Japan's international cooperation projects.

# Playing a Part in Japan's Development Assistance through the Tokyo International Conference on African Development (TICAD)

Africa, blessed with abundant natural resources and a population of some 1.4 billion people, is a continent poised for dynamic growth. At the same time, it faces numerous challenges including poverty, conflicts, terrorism, and inadequate infrastructure. The Government of Japan, since 1993, has provided ongoing support to African nations through TICAD, held in collaboration with the United Nations and other organizations. Centered on ownership and partnership, this support has been provided while recalibrating cooperative relationships to address the challenges of the times, such as peace and stability, human security, and the Sustainable Development Goals. JICS plays a role in these efforts as an integrator in the field of international cooperation. In this roundtable discussion, three professionals involved in African development assistance projects exchanged opinions about JICS activities in this area.

## Delivering equipment and materials quickly and reliably to where they are needed to sustain people's lives and safety

**Jo:** JICS has been involved in food assistance for 20 years. We procure food assistance for recipient countries, primarily in Africa, in collaboration with the Ministry of Foreign Affairs and the Ministry of Agriculture, Forestry and Fisheries. We work to ensure projects run smoothly by coordinating with recipient country governments, the Ministry of Foreign Affairs, embassies, and other stakeholders. More specifically, this work includes selecting suppliers to transport food assistance to the recipient countries and managing land and sea transport.

One project I was involved in was the fiscal 2023 Food Assistance Programme for Burkina Faso. This country receives frequent and

substantial food assistance, and its citizens prize Japanese rice in particular for being delicious. For this reason, both the Burkina Faso government and people eagerly anticipate Japan's food assistance. Unfortunately, because the country is landlocked, the food assistance must be transported by sea to neighboring countries for unloading and then moved by rail or truck to the final destination. The biggest concern with this Programme was the potential for disruptions during transit due to deteriorating security conditions. To address this, we maintained close communications with the government and suppliers and established a rapid response system in the event of any issues with transportation. As a result of this transportation management, the project was executed successfully.

When visiting recipient countries, it truly brings me joy to see Japanese

rice bearing our national flag that has been delivered through food assistance in local markets and to hear the local people say how delicious it is. These moments reaffirm to me that our mission is to deliver eagerly awaited food assistance to its destination without loss.

**Yoshimizu:** I'm involved in a fiscal 2024 project to procure landmine removal equipment to be sent to Senegal, located at the westernmost tip of the African continent. Senegal's border areas are riddled with landmines, and the inability to access these areas has severely hampered the country's economic activities. During my visit to Senegal, I listened to passionate accounts from the director of the Senegalese National Mine Action Centre and officials from the Ministry of Economy, Planning and Cooperation about their economic development aims through clearing

landmines in the target areas. This redoubled my awareness of just how important a responsibility we at JICS bear. At the same time, I feel what we are doing is very worthwhile, not just in procuring equipment and materials, but also in knowing that the procured landmine removal equipment will actually be put to use and help improve people's lives.

**Jo:** In the same fiscal year, we took on a new project that went beyond our regular procurement agent services. For a Ministry of Health, Labour and Welfare project to provide vaccines and syringes to the Democratic Republic of the Congo, where an mpox outbreak is spreading, JICS took on the role of supplier delivering the supplies to local destinations. This meant we were attempting operations quite different from our normal procurement agent operations. The project faced some initial difficulties, particularly in the international transport of the vaccines, which required both speed and rigorous temperature controls. However, we were able to deliver the vaccines and syringes to their destinations by leveraging our extensive knowledge of the area gained through years of experience and our broad domestic and international network, and with the cooperation of various stakeholders, including the Ministry of Health, Labour and Welfare, the Government of the Democratic Republic of the Congo, and the Embassy of Japan. We received messages of gratitude for the Government of Japan's assistance from the Congolese people.

### Contributing to livelihoods, healthcare, and education through facility construction initiatives

**Murayama:** In addition to procuring equipment and materials, JICS engages in facility construction projects that contribute to daily life

and education in African countries. One project I was in charge of called for the construction of 51 elementary schools (249 classrooms and toilets) in the Republic of Benin, which took about four years starting in fiscal 2007. Previous facility construction projects funded by Japan's grant aid involved Japanese construction consultants and contractors traveling to the sites to build the facilities. However, the Government of Japan ran Grant aid for community empowerment from 2006 to 2014, aiming to construct more schools with the same aid budget. The scheme emphasized incorporating local specifications and designs and the proactive hiring of local businesses and usage of local materials. JICS was involved in 39 projects under this scheme in Africa, with a total aid budget of approximately 42 billion yen. I was stationed in Benin as an Assistant Project Manager, conducting negotiations with the Ministry of Maternal and Primary Education of Benin, overseeing the bidding processes for selecting local construction consultants and contractors, and managing the project's progress. Hiring local construction consultants and contractors allowed for flexible responses tailored to local circumstances on one hand, but on the other, it was a challenging project requiring careful consideration for schedule management and quality assurance. Nevertheless, we successfully built 51 schools across four departments in three and a half years. Even now, whenever I'm in the country, I visit these schools. Seeing the teachers and children still using them with care, years later, always warms my heart.

**Yoshimizu:** In the area of facility construction, I am currently involved in a Project for Construction of the Health

and Social Promotion centers (CSPS) in 10 health administrative districts in Burkina Faso. The project includes drilling wells and installing incinerators and solar-panel systems to ensure the CSPS will be used sustainably over time.

JICS architects and experienced facility construction program supervisors conduct on-site surveys, coordinate with the Ministry of Health of Burkina Faso on construction requirements and other matters, and select local consultants and construction contractors. At JICS headquarters in Japan, I handle contract execution procedures and payment processing for the consultants and contractors. We communicate closely with staff in Burkina Faso using all available methods — email, online meeting tools, and phone calls — to ensure no misunderstandings arise when having them make inquiries, confirmations, or requests to consultants or contractors on our behalf.

Although I have not yet visited Burkina Faso, the monthly reports from the consultants give me an understanding of how the facility and well construction is progressing. This makes me feel involved in a major project and provides a sense of accomplishment.

### A JICS strength is our ability to adapt flexibly and broaden our operations to meet the needs of the times

**Jo:** The strength of JICS lies in how our vast experience and knowledge accumulated over time are shared among everyone and applied to new projects. When facing difficult decisions, consulting senior colleagues within the organization yields plenty of advice based on their wealth of experience. And with thorough records kept in databases and other

systems, we can make the maximum utility of JICS' stockpile of experience and knowledge when tackling new projects. Another JICS strength is our broad network domestically and abroad, including relations with the governments of recipient countries. This extensive international network is utilized to advance projects steadily with all parties working in collaboration.

**Yoshimizu:** When I joined JICS in 2023, I lacked sufficient knowledge not only about the procurement agent framework but also about equipment and materials in general. However, with guidance from senior colleagues within my own division and other divisions like the Technical Support Division, I was able to carry out procurement operations step by step — handling items like landmine removal equipment, medical devices, and fertilizers. I had a real sense that projects move forward through mutual support across JICS, transcending divisional boundaries.

**Murayama:** JICS today is involved in a wide range of projects. In the beginning however, we started with procuring raw materials like oil and iron. From there, we began to handle the procurement of equipment such as landmine removal equipment and medical devices. Now, we even manage facility construction projects such as schools and CSPS. JICS has broadened the scope of our operations to meet the needs of the times and requests from the Government of Japan. I believe this capacity to adapt flexibly is JICS' greatest strength. This adaptation is possible by leveraging the extensive experience and expertise JICS has built up over the years.

Regarding development assistance in Africa, projects in Francophone regions are managed by personnel proficient in French. This enables direct, smooth communications and strong

ties with recipient country governments, implementing agencies, and local staff members — another big strength of JICS.

### Identifying needs, connecting stakeholders, and translating aid into tangible outcomes

**Yoshimizu:** Our next goal is to enhance both the quantity and quality of communications with local staff members and other people on the ground. The COVID-19 pandemic pushed digital communication tools into the mainstream, enabling us to hold meetings with local staff members even in countries where entry is difficult due to deteriorating circumstances. Certainly, visiting sites and speaking in person remain important. But we believe it's equally crucial to choose the most suitable means for each occasion — be it phone, email, or online meeting tools — and maintain frequent, close communications.

**Jo:** It's a tremendous honor to be entrusted with a new project based on the belief that "JICS can get it done". I think this belief stems from successive generations of predecessors who carried out projects with diligence and dedication and then turned over their knowledge to the next generation. This is why I want to follow in their footsteps, committing myself to each project and ensuring their progress step by step, so that the people after me can make

use of the experience and knowledge I gain. I intend to continue to work while adapting as required to the needs of the times and striving to grow without being content with the status quo.

**Murayama:** Moving forward, we will focus on our primary operations as a procurement agent. For example, during the COVID-19 pandemic, we procured medical equipment and supplies for over 50 countries and, more recently, we have been engaged in procuring equipment and materials for Ukraine's recovery and reconstruction. In this way, we have quickly adapted our procurement agent services to meet the needs of the times. On the other hand, we intend to further broaden the scope of our operations. This includes supporting the international transport of vaccines and assisting the entry into new markets by private companies possessing outstanding technologies, products, and expertise that contribute to the SDGs. And as an integrator in the international cooperation field, we aim to contribute to the peace and stability of the international community by identifying and connecting the needs of various stakeholders, including the Government of Japan and recipient country governments, and then translating aid and international cooperation projects into tangible outcomes.

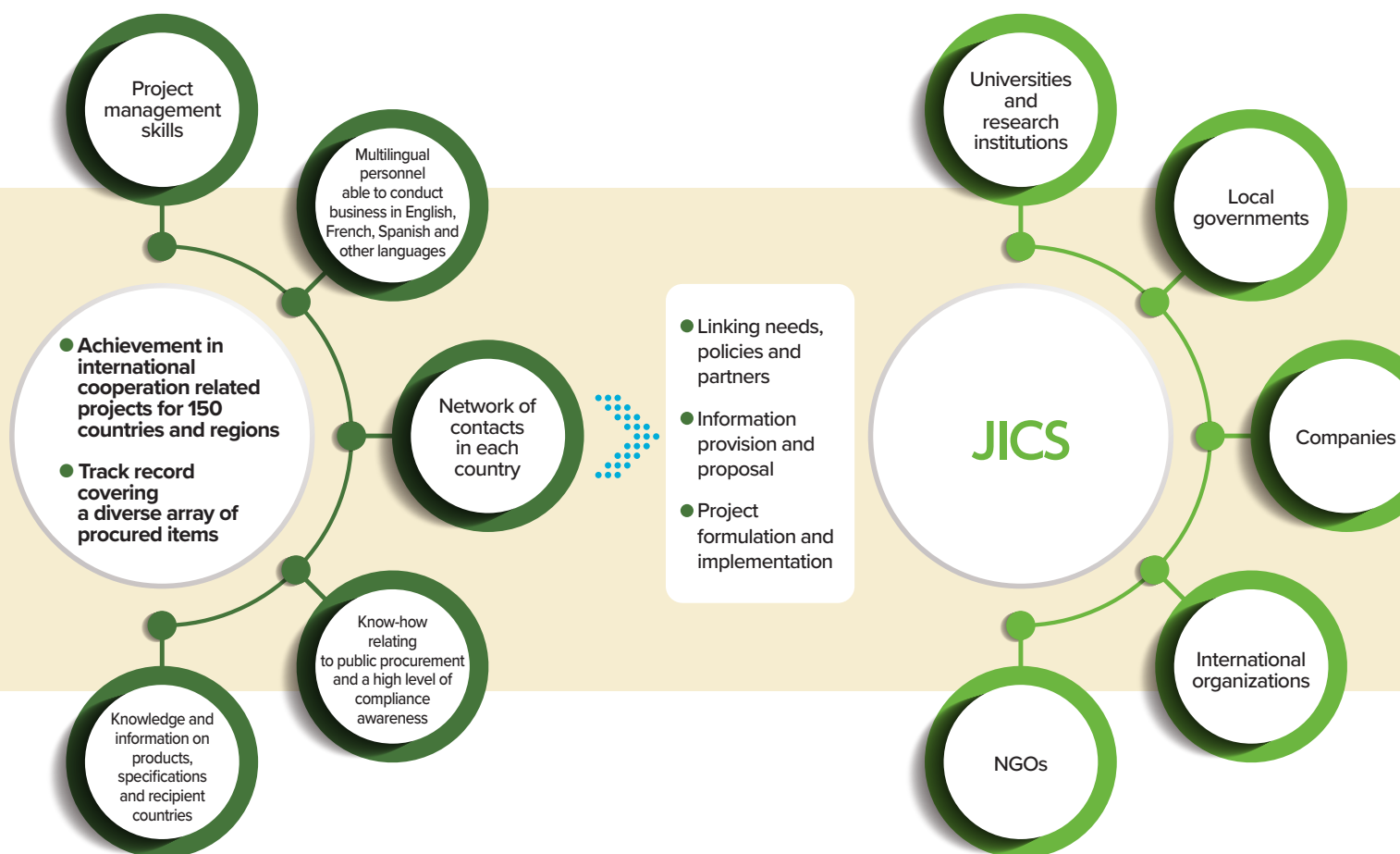

Within ODA-related projects and other international cooperation we must of course better understand the needs of recipient countries, but it is also important to work together to maximize the efficacy of projects in order to contribute to the resolution of issues facing the governments of recipient countries as well as peace and stability throughout the international community and achieve quality growth through efforts to address global issues.

Over the past 30 years, JICS has supported ties between the Government of Japan and the governments of recipient countries through procurement operations. By doing so, JICS has gained the understanding and cooperation of recipient-country governments and has worked to improve the

quality and ensure the transparency of grant aid and other international cooperation projects.

In addition to the Government of Japan and its affiliate agencies and recipient-country government agencies, various stakeholders such as companies, universities and research institutions, local governments and NGOs participate in international cooperation. To achieve a total win for each actor, it is necessary to build close, cooperative relationships.

From the perspective of “procurement,” JICS will provide services to connect everyone through procurement agent services, studies (consulting), facilitation of executing ODA projects, and screening and analysis.

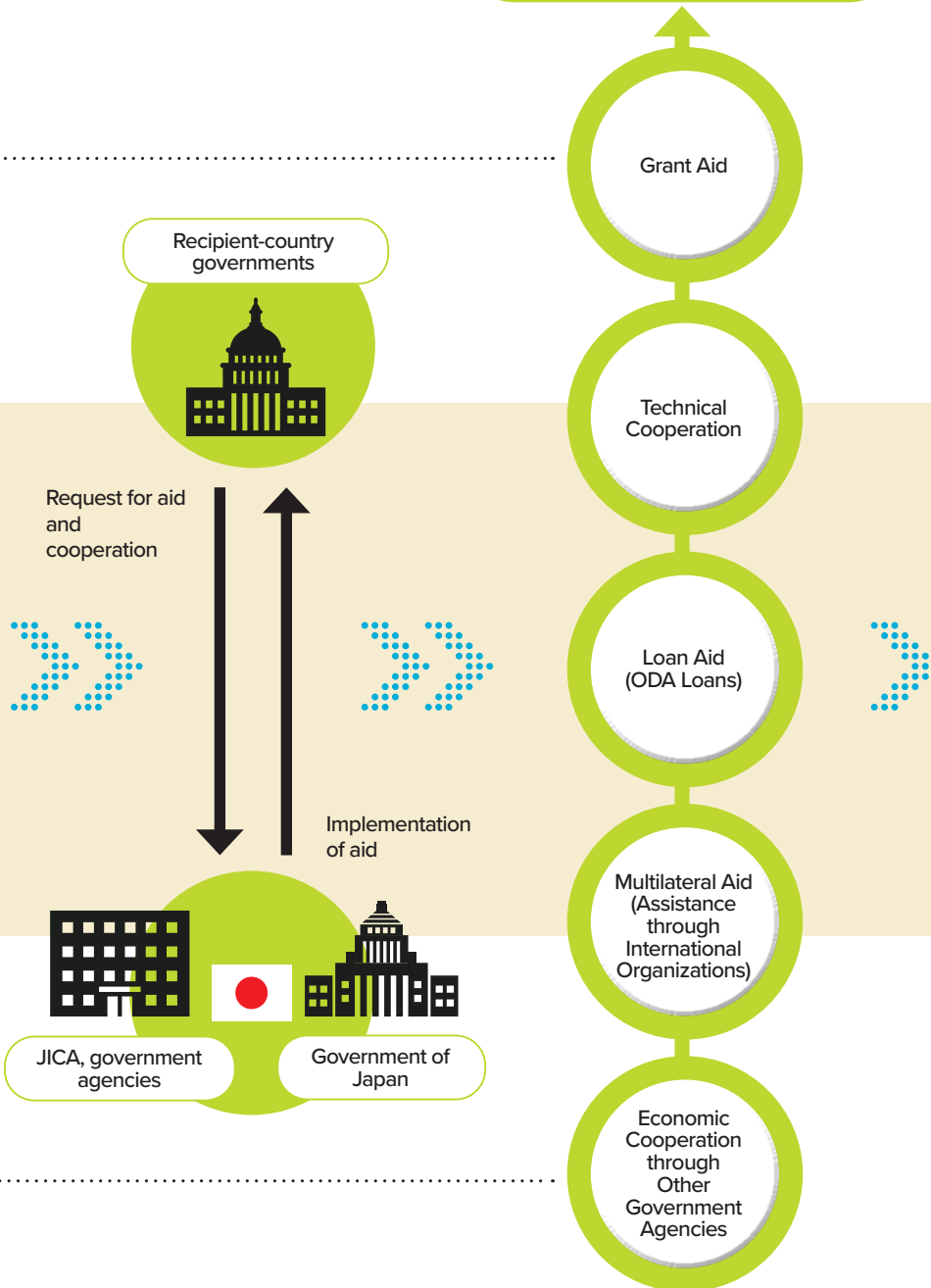

## Development Cooperation and the Role of JICS in ODA



### The Projects That JICS Undertakes Contribute to the Achievement of the Sustainable Development Goals (SDGs)\*

\* Sustainable Development Goals (SDGs): The development goals of the entire international community from 2016 to 2030, as listed in the “2030 Agenda for Sustainable Development” adopted at the United Nations Summit in September 2015.

#### ■ Operations Implemented in Grant Aid, Multilateral Aid-Related Projects

##### Procurement Agent Services

As the procurement agent on behalf of the recipient-country governments, JICS provides procurement services—including management of funds—and carries out project management.

- **Necessity of Procurement Agent** ..... To utilize funds—granted in accordance with Japan’s ODA rules—appropriately and expeditiously, a third-party organization that has a thorough knowledge of relevant rules carries out procurement procedures and manages the grant aid funds.
- **Main Operations** ..... JICS determines tender conditions by confirming the specifications for materials, equipment and facilities; the quantity of items; and delivery and construction conditions with the executing agency of the recipient country. JICS selects and enters into contracts with suppliers and construction companies through the tender process and supervises the contract fulfillment status of the contractors while managing the project’s funds.

##### Procurement of Products

JICS determines the equipment specifications and delivery conditions based on data related to the materials and equipment, and information regarding the customs clearance procedures as well as the systems to receive and store imported goods in the recipient country. To ensure that equipment is delivered in accordance with the contract, JICS carries out checks before shipping and in the recipient country.

##### Main Procurement Details

##### ● Description of JICS’ Activities

JICS managed entire projects as a procurement agent and procurement management services under Grant Aid for Conflict Prevention and Peacebuilding, which was implemented from fiscal 2005 to fiscal 2015. Our services included procurement of materials, equipment, and services as well as management of activities, for projects such as reintegration of former soldiers into society, small arms collection, ethnic reconciliation and demining and the like.

##### Procurement and Management of Construction

Based on the needs of the recipient country, JICS together with a construction consultant determines the facilities specifications and the construction conditions for the project.

During the construction period, JICS carries out project management.

##### Main Procurement Details

- ▶ Construction of elementary, junior high and teacher training schools
- ▶ Healthcare center construction ▶ Road renovations
- ▶ Project for introduction of clean energy by solar electricity, etc.

##### Grant Aid Projects under Public–Private Partnership

Management of projects supporting businesses such as the construction, operation and maintenance of facilities implemented by Japanese enterprises with expertise and urban infrastructure development cooperation leveraging Japan’s technologies and experience.

##### Main Procurement Details

##### ● Description of JICS’ Activities

JICS acted as procurement agent and conducted project management for the construction of elementary, junior high and teacher training schools under Grant Aid for Community Empowerment from fiscal 2006 to fiscal 2015.

#### ■ Operations Implemented in Grant Aid, Technical Cooperation, ODA Loans, Multilateral Aid-Related Projects and Other Economic Cooperation by Government Agencies

##### Studies (Consulting)

- ▶ JICS conducts surveys and analysis to propose optimal conditions for a project, such as the appropriateness of the needs, technical specifications and estimation.

### A Contributing Partner Protecting the Maldives' Azure Seas and Its National Interest

Grant Aid for the Economic and Social Development Programme

#### Procuring equipment that delivers long-term benefits to maximize the project's impact

Comprising some 1,200 atolls of varying sizes, the Maldives is a world-renowned resort nation synonymous with beautiful seas. As such, marine pollution, including dumping at sea, is a significant concern for the country. Since the Maldives relies on tourism and fisheries for the majority of its national income, combating marine pollution is directly linked to its national interests. For this project, JICS thoroughly investigated the conditions at the intended delivery sites while accounting for how equipment would be used in each region. Together with the recipient country's government, JICS reviewed the specifications for equipment designed for long-term use and then procured garbage collection trucks, wheel loaders, and other equipment.

#### Appropriate procurement of equipment boosts the reputation of aid from Japan

The Government of Japan's aid to the Maldives is prioritized on the environment, climate change action, and disaster mitigation. JICS currently engages in the procurement of equipment for the Maldives across many fields, including disaster preparedness and patrol boats for customs monitoring. Having collaborated with numerous Maldivian government agencies on past projects, JICS is widely recognized by Maldivian officials and we sense the elevated expectations placed on us as an aid organization. We carry out appropriate procurements and will increase the number of aid projects rated highly by the Maldives.

### Preventing the Spread of COVID-19 in Cambodia

#### Aiming to bolster Cambodia's public health and medical systems

Cambodia's internal medical systems are extremely fragile. Should COVID-19 infections spread within the country, there is a risk that infections will rapidly spread throughout the entire Mekong region. Immediately after the Government of Japan decided to provide grant aid for the procurement of public health and medical equipment for Cambodia, JICS promptly made the procurements and delivered the first shipment in August 2020, just two months after the decision.

#### Procured a long list of equipment to improve access to emergency medical care

Due to the pandemic, it was not initially possible to travel from Japan to Cambodia. Consequently, we made full use of local staff members and online meetings to work closely with the Ministry of Health of Cambodia. As a result, we successfully delivered more than 20 types of emergency medical care equipment by the end of 2022. After the equipment were delivered to the Ministry of Health warehouse in Phnom Penh, the Ministry distributed them to hospitals in the capital and provincial hubs in coordination with provincial health departments. The equipment continue to be used effectively, even now after the pandemic has subsided.

## Contributing to the Development of Sustainable Forestry in the Solomon Islands

Grant Aid for the Economic and Social Development Programme

### Aiming for the sustainable use of forest resources and improvements in the lives of forestry workers

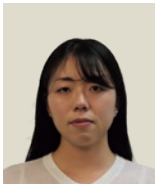
Forestry is a major industry in the Solomon Islands, as nearly 80 percent of its land is forested. However, the majority of these are privately owned forests and many places lack sawmill equipment, meaning forestry workers are forced to rely on the export of low-value raw timber. The portable sawmills procured under this project are intended to further the sustainable use of forest resources and improve forestry workers' livelihoods, while helping to minimize impacts on the natural environment.

### Rapid procurement based on stakeholders' needs

Making use of JICS's procurement expertise, we made extensive confirmation in advance of delivery site availability and transportation methods. We quickly coordinated with all stakeholders to ensure equipment matching the recipients' needs was delivered at the desired time. The 67 portable sawmills handed over were smoothly distributed to local communities, where they are expected to generate added value through timber processing and other activities.

## Aid for Sustainable Fishing in Tonga: Recovery and Development from an Undersea Volcanic Eruption

Grant Aid for the Economic and Social Development Programme

### Aiming to restore and revive Tonga's important fisheries industry

Fishing is a vital industry for the Kingdom of Tonga, but a 2022 eruption caused volcanic ash and a tsunami that damaged fishing grounds and fishing boats, leading to reduced catches. There were also concerns that volcanic ash contamination would affect water quality. Following a request from the Government of Tonga for fisheries-related equipment such as boats, water quality meters, and microscopes, the Government of Japan decided to provide grant aid to the country. JICS quickly began procedures to ensure prompt procurement of the requested equipment.

### Support the progress towards sustainable fisheries and aquaculture

Among the procured equipment, optical microscopes were procured for the Ministry of Fisheries of Tonga to use for research activities at its Aquaculture Research Center. The microscopes are used in research to count the number of larval cells (survival concentration) of farmed oysters, giant clams, and sea cucumbers as well as to estimate growth rates. The use of the microscopes is expected to spearhead development of sustainable aquaculture.

## Supporting Laying Submarine Cables to Kiribati and Nauru under the East Micronesia Submarine Cable Project

Grant Aid for the Economic and Social Development Programme

### Supporting the laying of submarine cables to the Kiribati and Nauru landing stations

The East Micronesia Submarine Cable Project, funded jointly by Japan, Australia, and the United States with a total budget of approximately 95 million U.S. dollars, consists of laying submarine cables, constructing Cable Landing Stations, and providing technical cooperation. JICS's role is to procure components for the submarine cable laying contract in collaboration with Australia and Australian-employed consultants. Using a submarine cable lay ship, Japanese-produced cable (approximately the thickness of a garden hose) and optical signal amplifiers (repeaters) will be laid along about 2,250 kilometers of seabed from Tarawa in the Republic of Kiribati to the Republic of Nauru and on to Pohnpei in the Federated States of Micronesia. The submarine cables will connect to Cable Landing Stations in four locations. The new cables will connect to the Micronesia landing point of the existing HANTRU-1 submarine cables linking Pohnpei and Guam, providing the beneficiary countries with a solid digital gateway to the world.

### A collaboration between six countries: Japan, Australia, the United States, Kiribati, Nauru, and Micronesia

For this collaborative project involving six countries, procurement management is conducted within the framework of grant aid for the economic and social development programmes between Japan and the beneficiary countries (Kiribati and Nauru). Consequently, JICS must propose and implement optimal solutions for each relevant agency while coordinating on details with stakeholders at different stages of the overall schedule. JICS continues to manage smooth and orderly procurements to ensure the digital connectivity environment for the region is realized on schedule, with completion planned for December 2025.

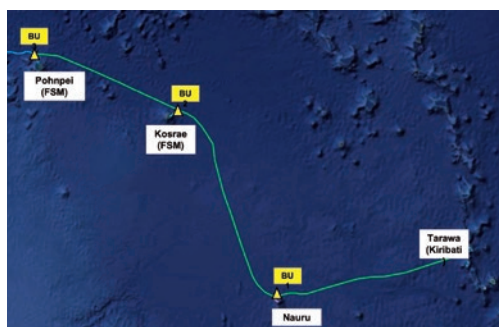

## Enhancing Jamaica's Public Safety Capacity

Grant Aid for the Economic and Social Development Programme

### Conducting the project appropriately with due consideration to the recipient country's laws and regulations

Violent crimes occur frequently in Jamaica. Although the country has public safety measures in place, involving both the police and the military, curbing crime remains elusive. The Government of Jamaica requested grant aid from the Government of Japan to procure such items as police vehicles that the country is short of. JICS quickly procured vehicles matching Jamaica's laws and requests, making use of our experience in procuring police vehicles for a range of countries.

### Aiming to improve public safety conditions through the procurement of equipment and materials

With significant support from the Embassy of Japan and cooperation from suppliers, patrol vehicles were successfully delivered to Jamaica. Deputy Prime Minister and Minister of National Security Horace Chan, at the handover ceremony, stated that the vehicles will play an important role in police operations and contribute to establishing an appropriate framework for Jamaica's public safety measures. To further contribute to the safety of Jamaican society, JICS continues to expedite the procurement of ambulances.

## Helping Procure Equipment for the Recovery and Reconstruction of Nicaragua's Public Infrastructure

### Recovery and restoration from hurricane damage and enhancement of disaster preparedness capacity

Two hurricanes that made landfall in November 2020 caused extensive damage in Nicaragua, including flooding due to river breaches and destruction of roadways. To restore damaged road networks and enhance its disaster preparedness capacity, the Government of Nicaragua requested grant aid from the Government of Japan.

### Expectations for roadway reconstruction using Japanese equipment

JICS's procurement procedures faced significant challenges, in part due to soaring global equipment and transportation costs. Thanks to the cooperation of suppliers and Japanese equipment manufacturers, we were able to meet nearly all the Government of Nicaragua's requests regarding equipment specifications and required quantities. The training sessions on equipment operations attracted many participants eager to help restore the disaster-affected areas and enhance the country's disaster preparedness systems.

## Equipment Procurements Tailored to End-user Requirements in Mongolia

Technical Assistance with Compiling Specification Documentation

### Procurement that accounts for the natural and social environments of the recipient country

I was in charge of preparing equipment specification documentation for the project of the “Last One Mile Support” for vaccine transportation in Mongolia. The equipment requested for procurement included vaccine refrigerated transport vehicles and sequencers as well as portable freezers for vaccinating nomadic populations and spirometers. JICS is handling the procurement of a wide range of equipment while accounting for the natural and social environments of the recipient country.

### Ensuring the quality of procured equipment

Ensuring the quality of procured medical equipment is especially important given their impact on patient lives and the quality of treatments. The level of support provided by candidate manufacturers after equipment deliveries is also a major factor influencing the selection of equipment. To guarantee that appropriate equipment of appropriate quality reaches the delivery locations, we apply standards and requirements that procured equipment must meet, including the medical equipment registration system within the recipient country as well as certification systems in Japan, Europe, and the U.S., or those of international organizations.

### Promoting rapid procurement with hope for peace and stability in Ukraine

The Russian military invasion of Ukraine that began in 2022 continues unabated, now passing the three-year mark. The country's infrastructure has been severely damaged, making daily life for its citizens extremely difficult. JICS has signed procurement agent agreements with the Government of Ukraine for nine sub-projects under its purview. We have delivered aid supplies to a total of 46 end-users in major cities including Kyiv, Kharkiv, Dnipro, Mykolaiv, and Kherson. JICS continues to cooperate in supporting Ukraine's reconstruction through rapid procurements.

## Pushing to Further Improve JICS Service Levels Both Domestically and Globally

### Striving to enhance staff capacities through broad training

The Coordination Office held 18 training sessions in fiscal 2024, with the participation of over 550 employees in total. Topics covered a wide range, including aid-related agreements, contracts, technical specifications, and English usage. Post-training surveys are conducted after each session as a means to further enhance training. JICS works to improve staff capacities and share knowledge in order to ensure the delivery of consistently high-quality services.

### Efforts to align operations with local staff members

JICS shares basic rules on the execution of operations with local staff members working worldwide to ensure they perform administrative tasks in step with headquarters. As part of this effort, in fiscal 2024, we confirmed the Code of Conduct, reached a shared understanding of compliance, and worked to bolster risk management with all 25 staff members in 22 countries. JICS will continue to strive to provide appropriate operations and services in concert with local staff members in each country.

## Leading Procurement in the Security Sector

### Official Security Assistance (OSA)

### Using our ODA procurement experience to help fast and reliable implementation of OSA operations

Over our 36 years since our establishment, JICS has been involved in over 1,500 ODA procurement projects in more than 155 countries. In recent years, we have accumulated extensive experience, particularly in maritime security safeguarding Japan's sea lanes and in countermeasures against piracy and terrorism. We will make use of this track record to quickly and reliably advance operations to assist the stabilization of security environments for Japan and like-minded nations in the new field of OSA.

### Strict information controls and establishment of a new division

OSA provides support to militaries and other entities in various countries, which frequently involves accessing information related to the partner nation's security. Therefore, JICS requires every staff member involved to approach their duties with a high level of compliance awareness. Furthermore, on June 1, 2025, we established the new Security Support Division dedicated to overseeing OSA projects. Building on our stockpile of procurement expertise, we will lead procurement in the security sector while maintaining a high level of compliance awareness.

#### Providing Support to Create Better Security Environments

Official Security Assistance (OSA) is a new grant aid programme established in fiscal 2023. Its purpose is to respond to the security needs of like-minded countries and create a desirable security environment for Japan. The Government of Japan has decided to provide OSA support to eight countries at present, and we are pushing forward with procurement, particularly equipment for surveillance and monitoring.

## International Transport and Related Management Operations Delivering Mpox Vaccines to the Democratic Republic of the Congo

### Tackling a challenging project by using our past vaccine procurement experience

This was an extremely difficult project to safely deliver mpox vaccines, which require strict temperature controls, to the Democratic Republic of the Congo, where an mpox outbreak was growing more severe. JICS engaged in extensive discussions with various stakeholders to determine the best transport method. With flight availability fluctuating and deadlines looming, everyone involved worked as a team to ensure the deliveries were successful.

### Helping save lives during public health crises

One global problem is that many countries, including the Democratic Republic of the Congo, still suffer from severe sanitation issues. To address this pressing issue that threatens lives, JICS has collaborated with numerous stakeholders from multiple organizations both within and outside Japan to build up robust cooperative frameworks. These frameworks have enabled the prompt and safe delivery of technologically advanced vaccines produced in Japan. In response, local communities have expressed their gratitude to the Government of Japan for the vaccines.

### Supporting procurement procedures as a member of the executing entity's PMU

JICA has dispatched a procurement support advisor, an individual engaged in the project, to the Government of the Maldives, and our procurement specialist supports the implementation of procurements as an international consultant to the Project Management Unit (PMU) established within the executing entity. As the project is implemented by means of collaboration among numerous stakeholders, coordinated communications among the relevant parties and the execution of proper procurement procedures, without redoing or duplicating work, are essential for smooth progress of the project.

### Harmonization of JICA ODA Loan regulations with Maldivian Government regulations

In general, the yen-loan regulations on procurements apply to the project. Where these conflict with Maldivian government's procurement regulations, the differences must be analyzed and adjustments made, taking into account contract management considerations. 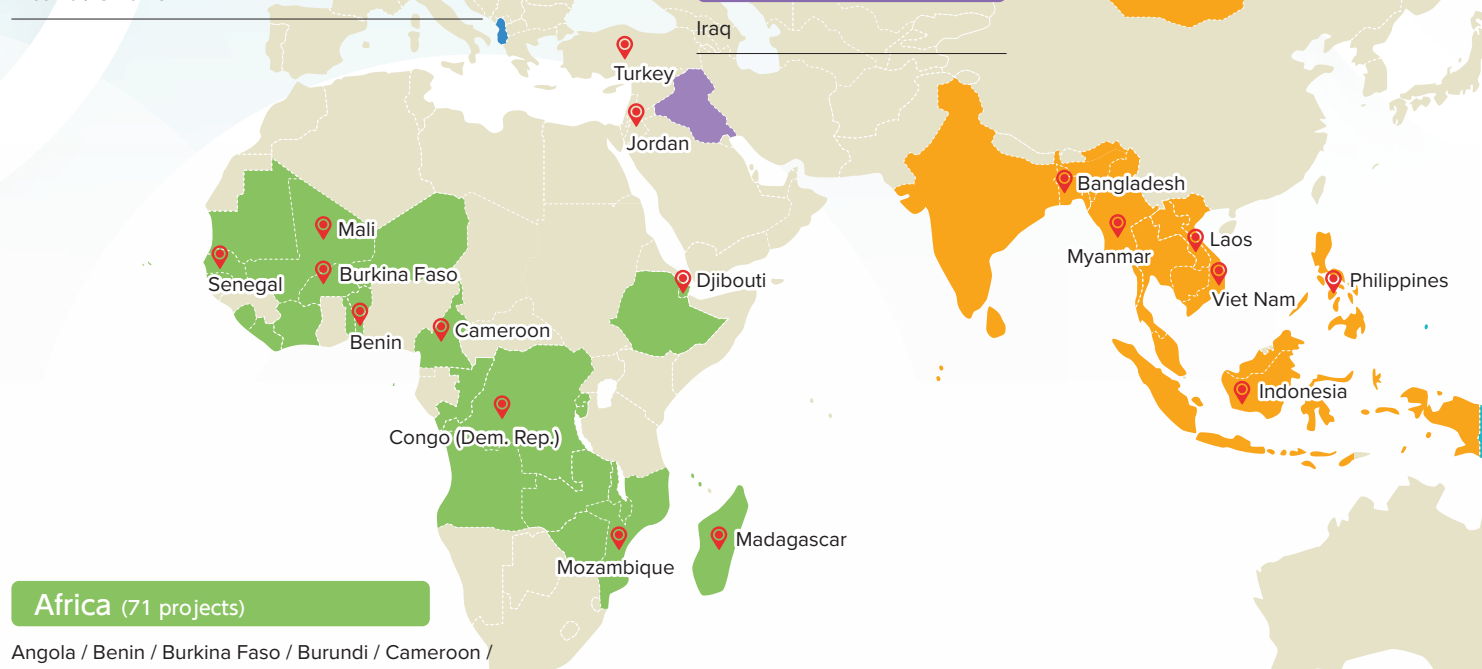

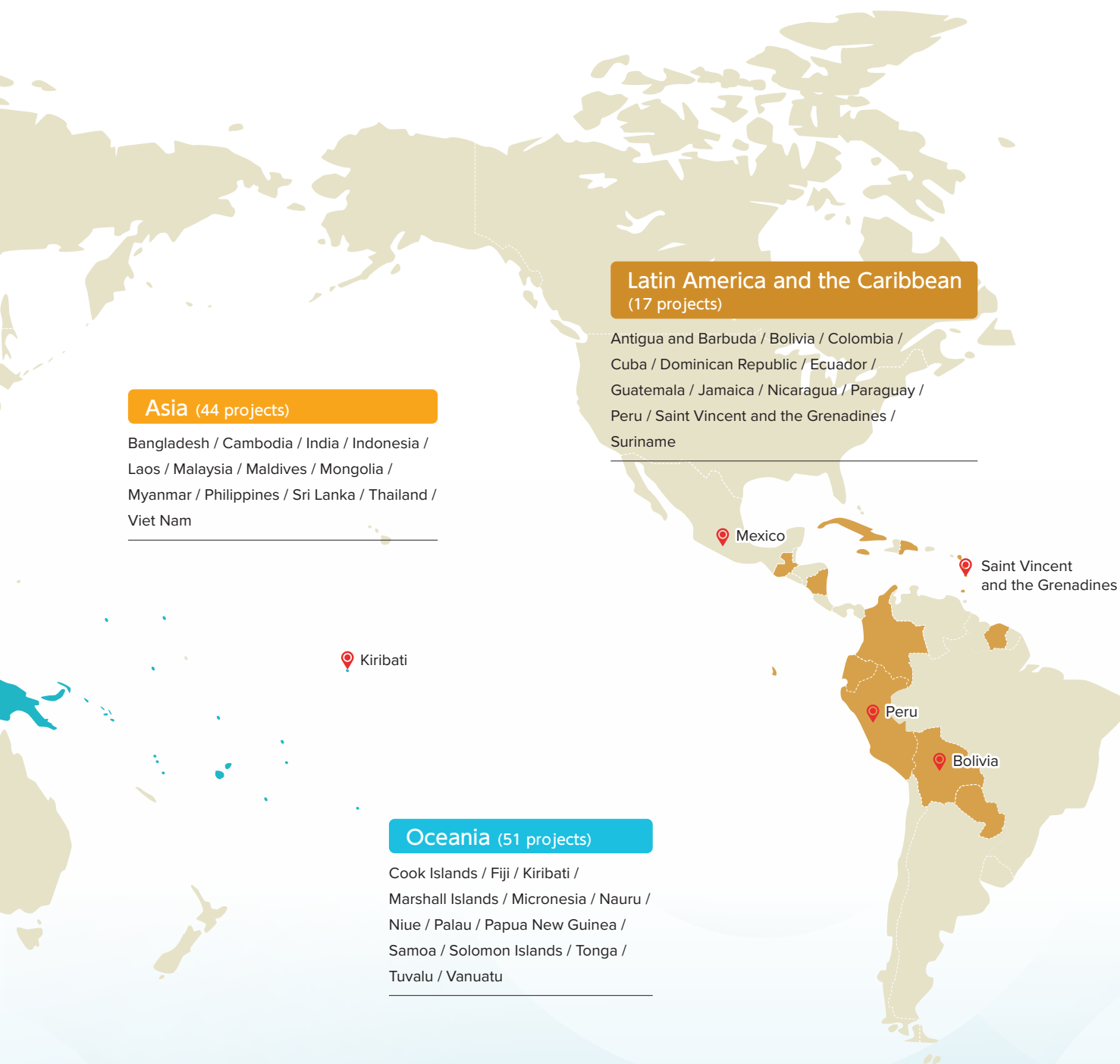

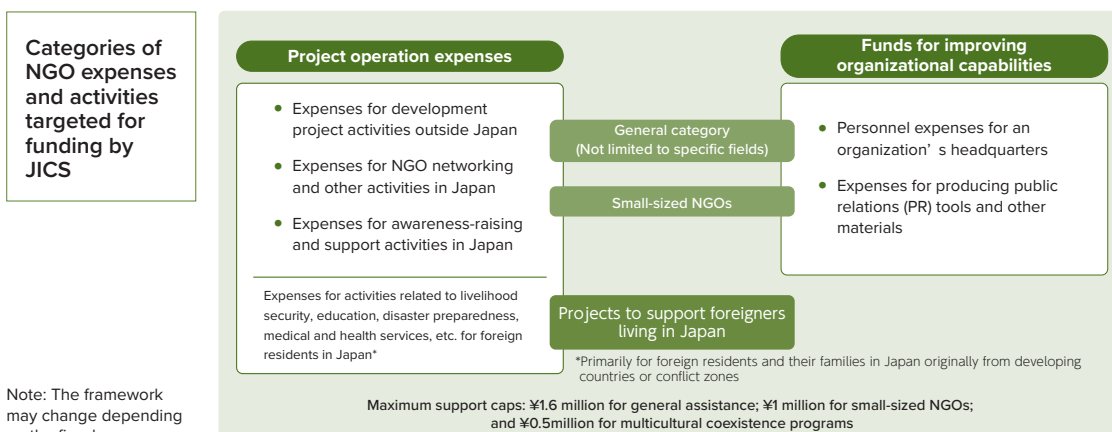
—Using JICS' NGO Support Program to Contribute to the Expansion of International Cooperation Activities by Private Organizations—

### Summary of NGO Support Program and Selection of Organizations to Support in Fiscal 2024

JICS provides funding to assist small- and medium-sized Japanese NGOs and NPOs (hereafter, collectively referred to as “NGOs”) that assist developing countries. JICS considers it one of its ESG initiatives to support community organizations and NGOs that are working to help achieve the SDGs. Its aim is to realize a society in which no one is left behind in the face of poverty, hunger, conflict, environmental destruction, disasters and other

global issues. This program involves providing support to between 7 and 10 organizations per year following the framework shown in the figure below. JICS has provided a total of ¥250 million in assistance (to 267 organizations) between fiscal 1999 and fiscal 2024.

In fiscal 2024, the Selection Committee chose to support eight organizations out of the 20 that applied. JICS holds a meeting for NGOs to report on their activities and share ideas with outside experts after completion of their support project. In fiscal 2024, we held a hybrid online and face to face meeting.

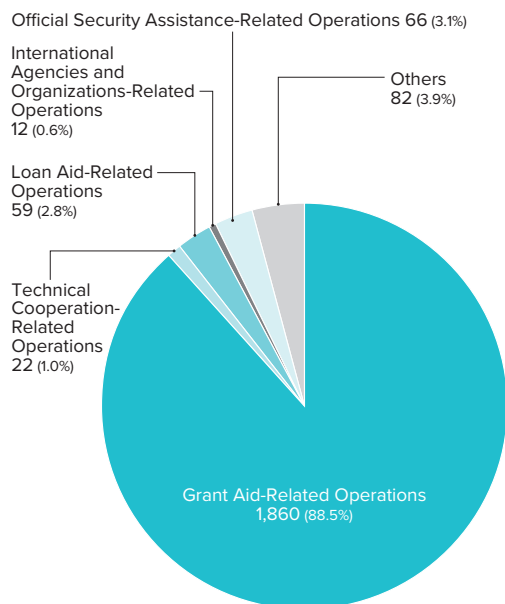


## Current Profit by Type of ODA and Client (FY2024)

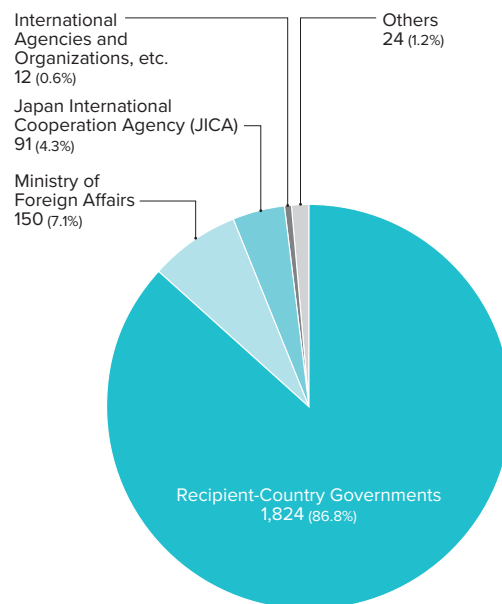
Current Profit by Type of ODA (FY2024)

Current Profit by Client (FY2024)

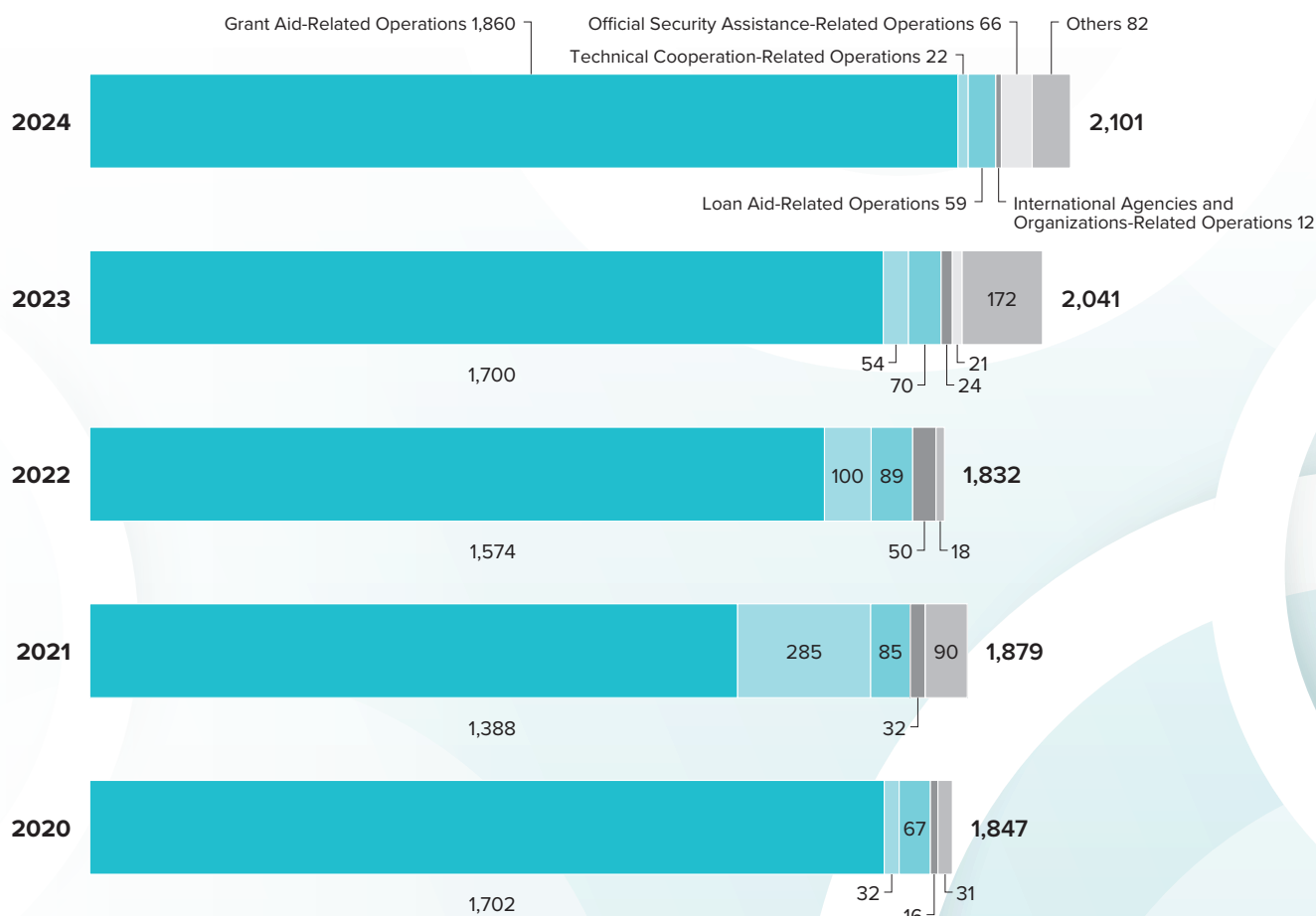

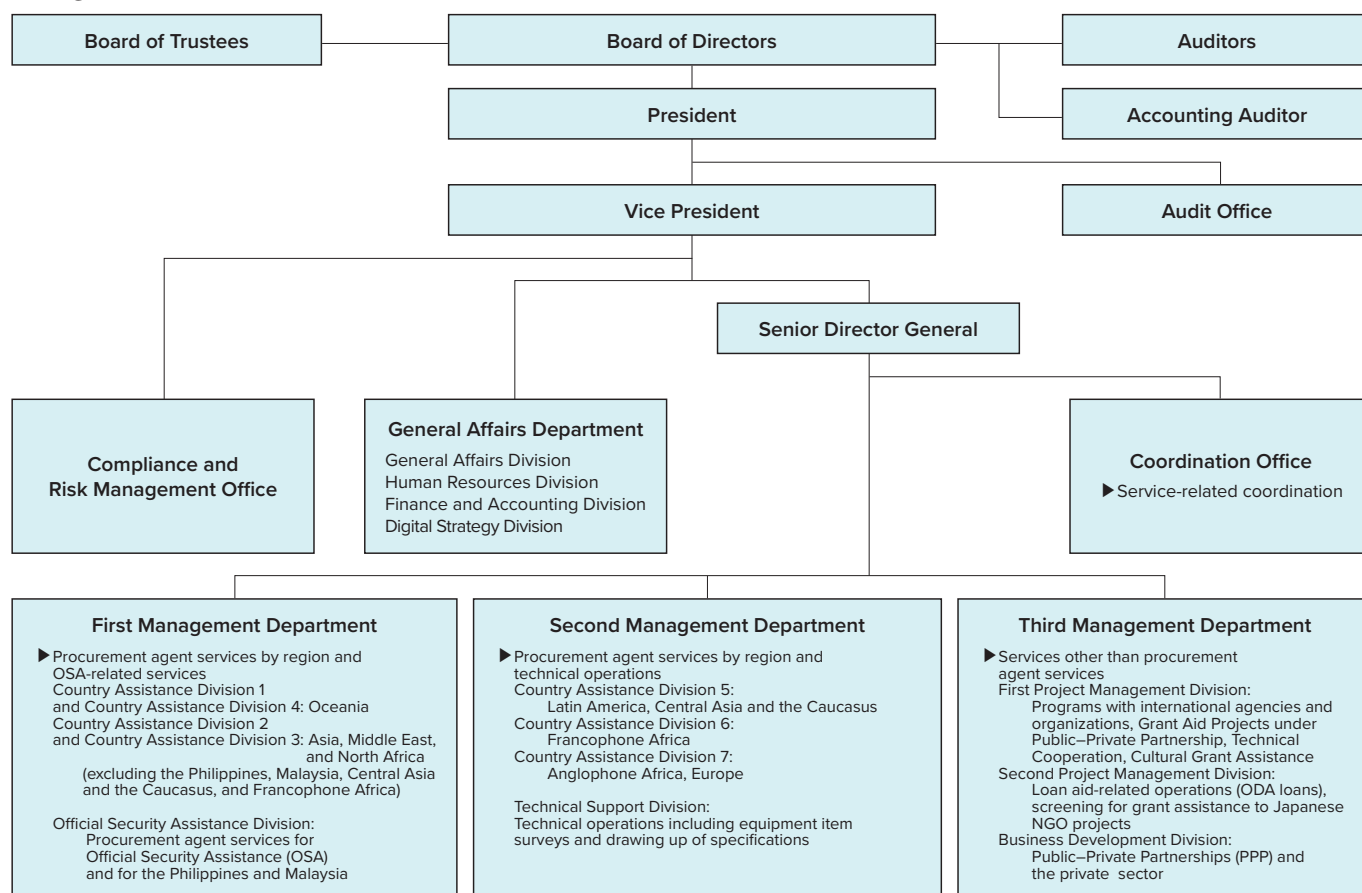
