

## To individual


- Be isolated and separated

# To Police


- \* Find difficulty to fulfill the duties of keeping security and safety for civilians

- Impede development in all fields
- Lack of physical infrastructure such as schools, roads, bridges, ponds, well, etc
- Short of health service
- Health condition of the community becomes worse
- Cause rich and educated people fleeing to live in other areas, causing the shortage of human resources
- No people from other places invest or do businesses on the products made by the community
- No organizations come to develop in the community
- Become insecured, have robberies and thieves, and rapes
- Create mistrust and lack of confidence in the community
- Live in fear damaging the mental ability





#### **Surrender Weapons**

#### **Have or Hide Weapons**

If you surrender all weapons during JSAC's project....

- no punishment
- receive development from JSAC
- obtain security, safety and peace

If you keep illegal weapons....

- be punished when JSAC project is finished
- o no development
- community may have armed violence and crimes

JSAC cooperates with the Royal Government of Cambodia to collect, destroy illegally widespread weapons left after civil war to reduce and prevent armed violence so as to build up a long term peace in the country.

The mandate of JSAC is limited, so the period of surrendering weapons without punishment in addition with development, when ALL the weapons are collected from the community, is also short.

On the other hand, please be aware that after JSAC project is finished in the near future, **person who has unauthorized** weapons must be punished under the Arms Law.

Don't hesitate to surrender weapons to the competent authority now.

The Management of Weapons, Explosives and Ammunition

Chapter 4

Penalty

#### Article 20 .-

For those who equip, carry, possess, utilize, sell, purchase, lend, transfer, distribute, hire, fabricate, improvise and repair weapons, explosives and ammunition of any and all types without authorization shall be liable to imprisonment from 6 (six) months to 2 (two) years and a fine from 500.000 Riel (five hundred thousand Riel) to 2.000.000 Riel (two million Riel), without taking other criminal acts into account.

#### Article 21.-

For those who are careless by allowing other people to use weapon, explosives, and ammunition, which fall under oneself possession, shall be liable to imprisonment from 1 (one) year to 2 (two) years and a fine from 700.000 (seven hundred thousand Riel) to 2.000.000 (two million Riel).

#### Article 23.-

For those who produce, trade in, transit, export, import, or stockpile weapons, explosives and ammunition of any and all types without permission shall be liable to imprisonment from 5 (five) years to 10 (ten) years.

After JSAC project is finished in your province, anyone who possesses illegal weapons will be punished under the Arms Law.

#### What are duties of police?



The primary duty of police is

To protect civilians from crimes based on law and human rights.

Serving the nation and civilians is the duty of police

Security forces can guarantee the security, safety and community order only in gun-free society.


